We have established a robust management framework to oversee both our involvement in climate advocacy and our engagements as members of trade associations. Notably, we have forged significant partnerships with esteemed associations that advocate critical goals such as Decarbonization and Responsible Product Stewardship which closely align with our targets. Oversight: The Director signing this Policy is accountable for the Policy and Unit Heads are responsible for implementing the policy at their respective sites.

Aditya Birla Chemicals (Thailand) Limited shall endeavour to:

- Maintain legal compliance to environmental regulations
- Develop, implement and maintain an internationally accepted environmental management system in our operations and new projects
- Prioritise initiatives aimed at continual improvement through pollution prevention, biodiversity protection, efficient use of resources and energy in alignment with international standards and best practices
- Follow waste management hierarchy Prevent, Reduce, Reuse, Recycle and Recover in the Treatment & Disposal of waste and implement strategies to promote circular economy to conserve natural resources

- Improve the environmental performance of products by implementing strategies and technology solutions to conserve natural resources, encourage research and development to identify innovative ways to avoid, minimise, and mitigate adverse environmental impacts, and focus on developing sustainable new products and production in methods with lower carbon and environmental impacts
- Recognise and act on the urgent need to address climate change and with the objective
 of reducing environmental impact. This involves taking proactive steps to decrease our
 greenhouse gas and non-greenhouse gas air emissions by setting targets for emission
 reduction
- Acknowledge the importance of preserving biodiversity and ecosystems and work to minimise our impact on habitats and species through responsible land use practices, habitat restoration efforts and biodiversity conservation initiatives
- Align our value chain to adopt principles of Aditya Birla Chemicals (Thailand) Limited Environmental Policy.
- Monitor, measure and report the progress on the performance of environmental conservation and management initiatives, including environmental risks and issues, in compliance with internationally recognised protocols and communicate approach and achievements to relevant stakeholders
- Undertake internal and third-party audits at regular intervals to assess environmental performance and conduct due diligence during mergers and acquisitions

Develop and follow an appropriate communication framework to engage with external stakeholders and wider communities to broaden our understanding of environmental priorities, their links to global issues and initiate actions on key environmental challenges.
